

# WTBOA Sale Check List 2019

In order to have the sale run as smoothly as possible and help keep consignors on track for the various sale deadlines, the WTBOA Sales Committee has provided consignors and agents with the following sale check list. - Fri., March 29** – “Early Bird” deadline for nominations to Summer Yearling session of August sale.
- Fri., April 26** – Final deadline for nominations to Summer Yearling session of August sale.
- Mon., May 13** – Deadline for Mixed session entries into August sale.
- Fri., June 7** – Deadline for final entry fee (\$325) for yearlings nominated to Summer Yearling session.
- Fri., July 5** – Deadline for stall card waivers to be in Sales Office.
- Fri., August 2** – Tentative deadline for Paddock session entries to August sale.
- Tues., August 6** – \*Deadline for all The Jockey Club Certificates of Registration to be in Sales Office.
- Tues., August 6** – \*Deadline for negative Coggins certificates.  
*Note: If coming from out of state and you require a Coggins for shipping, a legible copy of the Coggins must be in the Sales Office by the August 6 date and original Coggins must be handed into the Sales Office upon arrival at sales grounds.*
- Tues., August 6** – \*Deadline for Colt/Ridgeling status reports.
- Tues., August 6** – \*Deadline for EVA tests and/or entry permits on all ungelded male horses, who at six months or older upon entering the State of Washington, had tested positive for EVA.
- Wed., August 7** – Earliest date Broodmare/Broodmare Prospect status reports may be done.  
*Note: Once pregnancy is confirmed, consignor must expedite the service certificate to Sales Office.*
- Mon., August 12** – Deadline to submit sale horse photos to WTBOA website.  
*Note: Photos submitted past this deadline through Sat., August 17, will be posted at a cost of \$25 per photo, unless you are a display advertiser in either the Summer issue of Washington Thoroughbred or the sales catalog. No photos will be posted online after the August 17 deadline.*
- Thurs., August 15** – Barns open for dropping off equipment.
- Fri.-Sat., August 16-17** – Stalls ready for horse occupancy. Horses arrive.
- Fri.-Sun., August 16-18** – \*Out-of-state brand inspections, where applicable, due in Sales Office upon arrival at sales grounds.
- Sun., August 18, 9 am** – All horses available for viewing (including Paddock session entries). Any horse shown before Sun., August 18, is shown at one's own risk.
- Sun., August 18, 12 noon** – All Paddock session horse paperwork due in Sales Office.
- Mon., August 19** – \*Deadline for Broodmare/Broodmare Prospect status reports due in Sales Office.
- Mon., August 19, 3 pm** – Deadline for any last minute catalog corrections, additions or changes (must be turned in to Sue).
- Tues., August 20, 12 noon** – Deadline for sale reserves (must be written) to be turned in to General Manager Anne Sweet.
- Tues., August 20, 2 pm** – WTBOA Summer Yearling and Mixed Sale starts.
- Wed., August 21, through 2 pm** – Consignors responsible for care of sales horses.

**\* All August paperwork deadlines will be strictly enforced with a \$50 penalty for each late document.**
