☐ Fri., April 29 – Final deadline for nominations to Summer Yearling Session of August sale.
☐ Mon., May 9 – Deadline for Mixed Session entries into August sale.
☐ Wed., June 1 – Deadline for final entry fee (\$325) for yearlings nominated to Summer Yearling Session.
☐ Fri., July 3 — Deadline for stall card waivers to be in Sales Office.
☐ Wed., July 27 — Deadline for Paddock Session entries to August sale.
☐ Tues., August 9 — *Deadline for all The Jockey Club Certificates of Registration to be received by (paper) or digitally assigned (electronic certificate) to the WTBOA.
☐ Tues., August 9 — *Deadline for negative Coggins certificates. Note: If coming from out of state and you require a Coggins for shipping, a legible copy of the Coggins must be in the Sales Office by the August 4 date and original Coggins must be handed into the Sales Office upon arrival at sales grounds.
☐ Tues., August 9 — *Deadline for Colt/Ridgeling status reports.
☐ Wed., August 10 — Earliest date Broodmare/Broodmare Prospect status reports may be done. Note: Once pregnancy is confirmed, consignor must expedite the service certificate to Sales Office.
Mon., August 15 – Deadline to submit sale horse photos and videos for WTBOA website, online bidding platform at wtboa.equibid.com, and Equineline.com Sales Catalog App for iPad. Note: Photos submitted past this deadline through Sat., August 20, will be posted at a cost of \$25 per photo, unless you are a display advertiser in either the Summer issue of Washington Thoroughbred or the sales catalog. No photos will be posted online after the August 21 deadline.
☐ Thurs., August 18 — Barns open for dropping off equipment.
☐ FriSat., August 19-20— Stalls ready for horse occupancy. Horses arrive.
☐ FriSun., August 19-21 — *Out-of-state brand inspections and health papers, where applicable, due in Sales Office upon arrival at sales grounds.
☐ Sun., August 21, 9 am – All horses available for viewing (including Paddock session entries). Any horse shown before Sun., August 21, is shown at one's own risk.
☐ Sun., August 21, 12 noon — All Paddock session horse paperwork due in Sales Office.
☐ Mon., August 22, 3 pm – *Deadline for Broodmare/Broodmare Prospect status reports due in Sales Office.
☐ Mon., August 22, 3 pm — Deadline for any last minute catalog corrections, additions or changes (must be turned in to Sue).
☐ Tues., August 23, 12 noon — Deadline for sale reserves to be turned in to General Manager Ann-Kathrin Zemann. Must be submitted in writing on official WTBOA Reserve Directive form.
☐ Tues., August 23, 2 pm — WTBOA Summer Yearling and Mixed Sale starts.
☐ Wed., August 24, through 2 pm — Consignors responsible for care of sales horses.
